Battery Replacement Instructions



WARNING

DO NOT REMOVE ANY BOLT(S) HOLDING THE HYDRANT TOGETHER BEFORE THE HYDRANT IS DE-PRESSURIZED.

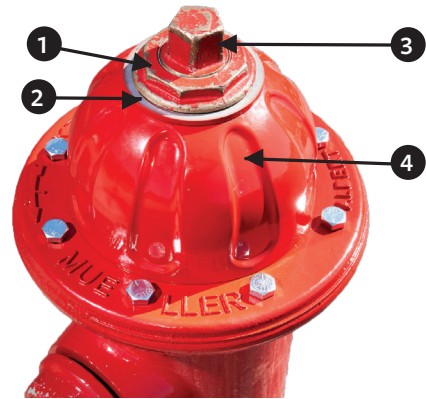

Tools needed

- A-311 Hydrant Wrench

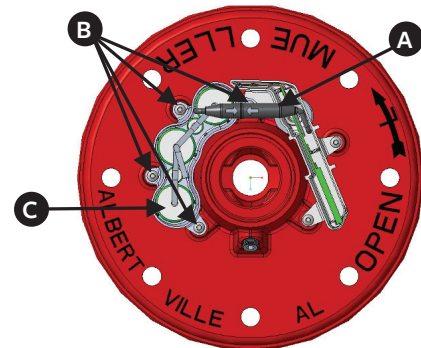
Part 1: Accessing the battery

1. Remove hold down nut (1) with A-311 wrench by rotating the hold down nut opposite the opening direction.
2. Remove washer (2).
3. Remove operating nut (3) with the A-311 wrench by rotating it in the opening direction.
4. Remove the bonnet cover (4).



Section 2: Replacing the battery

- E. Unplug battery assembly (C) from electronics assembly (A).
- F. Remove 4 screws (B) securing the battery assembly (C) to the bonnet.
- G. Take out battery assembly (C) and replace with new assembly.
- H. Secure with 4 screws (B).
- I. Plug new battery assembly into electronics assembly (A).
- J. Reverse steps in part 1.
