All major castings (Shoe, Lower Barrel, Upper Barrel and Caps) are primer coated with PPG Amercoat® 370 epoxy inside and out. Amercoat 370 is AWWA C550 compliant and NSF Certified. Above ground exterior will be top coated with Sherwin-Williams Polane® SP polyurethane enamel.
